Publication of the List of Successful/ Qualified Nominees: 21/10/2025 at 03:00 P.M.

Dates for Campaigning: From 22/10/2025 To 23/10/2025 Till 4:00 P.M.

Date of Election: 25/10/2025 (SATURDAY),

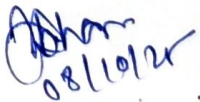
Voting Period: From 09:00 A.M. to 01:00 P.M. (At J.B. Law College, Auditorium)

Counting of Votes: 25/10/2025 From 02:00 P.M. onwards.

Rules and Regulations for Conducting the Elections of the J.B. Law College Students' Union (JBLCSU)

1. In compliance with the Hon'ble Supreme Court of India's directives and the Lyngdoh Committee Guidelines (2009), the elections to the Students' Union of J.B. Law College shall be conducted in a free, fair, and transparent manner.
2. The College recognizes that student representation is vital for the holistic development of students. Therefore, the institutional statutes shall provide for such representation.
3. The mode of election shall ordinarily be by direct elections, wherein all students of the College shall have the right to vote directly for the office bearers of the Students' Union.
4. In circumstances where the campus atmosphere is not conducive to peaceful and fair elections, the College may adopt a system of student representation through nominations. Such a system shall only be used as an interim measure, given its limitations and drawbacks.
5. The College administration strictly mandates the disassociation of student elections from political parties. Student elections and representation shall remain independent of political affiliations.
6. During the election period, only bona fide regular students on the rolls of the College shall be allowed to participate in the election process in any capacity.
7. Any violation of this rule, by candidates, student organizations, or others, shall invite disciplinary proceedings and may also lead to the revocation of candidature or disqualification from the election process.
8. Students must present a valid and up-to-date College Identity Card for filing nominations as well as for casting their votes on the election day, and wearing the prescribed college uniform is compulsory.

Eligibility

- a) Undergraduate candidates must be between 17–22 years of age; Postgraduate candidates up to 24–25 years;
- b) Candidates must be regular, full-time students with no academic arrears and a minimum of 75% attendance (or higher if prescribed by Gauhati University).
- c) Candidates must not have any criminal record or have faced any disciplinary action.
- d) A candidate may contest only once for an office-bearer post and twice for an executive member post.

Code of Conduct

- a) Campaigning must remain within the campus; use of printed posters, pamphlets, loudspeakers, vehicles, or animals is strictly prohibited.
- b) Only hand-made posters are allowed at designated places notified by the Election Officials.
- c) Appeals to caste, community, religion, or personal character are prohibited.
- d) Bribery, intimidation, impersonation of voters, or canvassing within 100 meters of polling booths is banned.
- e) No eatables or consumables other than water shall be distributed on the polling day.
- f) All candidates are jointly responsible for cleaning the polling area within 48 hours of polling.

Grievance Redressal

- a) A Grievance Redressal Cell headed by the Principal (In-Charge) shall address all complaints related to election conduct, campaign violations, or financial irregularities.
- b) Complaints must be filed within one week of declaration of results and will be disposed of within 24 hours of receipt.

Maintenance of Law and Order

- a) Any incident of lawlessness or criminal offence during the election shall be reported to the police within 12 hours.
- b) The College reserves the right to cancel or postpone elections in case of serious disturbance to peace and order.

All students are directed to adhere strictly to the above guidelines. Any violation will invite strict disciplinary action, including cancellation of candidature or elected post.
