**Final Mop-Up Admission Round for the 5-Year B.A. LL.B. Programme
(Academic Session 2026–2027)**

This is for the information of all concerned that, pursuant to the Notification no. GU/Acad/2026/Noti./2995 issued by Gauhati University regarding the Final Mop-Up Admission Round for the 5-Year Integrated B.A. LL.B. Programme (Academic Session 2026–2027), the admission process for the remaining vacant seats at J.B. Law College shall be conducted on 24th July, 2026 to 25th July, 2026.

The vacant seat details are as follows

STP:	1
EWS:	5

The Admission process at J.B. Law College for the Final Mop-Up Admission Round will be as follows:

- Candidates are required to fill out the Online Admission Form through the link provided below the notice to be considered for admission by **24th July, 2026 4PM**.

- Candidates will receive calls from the College after 4PM on **24th July, 2026** offering admission at J.B. Law College in **order of merit** based on their CAT RANK. If the call from the College is not responded the seat will be offered to the next eligible candidate.
- After confirmation from the candidate over call, candidates will be mailed the payment details and link through e-mail whereby candidates will have to pay the admission fee within the time that will be mentioned in the said e-mail. Failing to make the payment will result in the seat being offered to the next eligible candidate.

Eligibility

The following candidates are eligible to participate in the Final Mop-Up Admission Round:

- Candidates who appeared in the CAT-2026 for the 5-Year Integrated LL.B. Programme, whose names appear in the published University Rank List, and who have **not been admitted in any previous admission round**; or
- Candidates who were allotted a seat in an earlier round but subsequently **cancelled their admission and returned the allotted seat**, provided their names continue to appear in the valid University Rank List.

Candidates who have already confirmed and completed their admission in any previous round and are currently enrolled are not eligible to participate in this Mop-Up Round.

Important Instructions

- Candidates allotted admission at J.B. Law College must **complete the online admission process within the stipulated period**.
- Candidates must **physically report to the College on or before 24th and 25th July, 2026**, along with all original documents for verification. Failure to report within the prescribed period, without prior written intimation to the Principal, shall result in cancellation of the admission.
- All admissions shall remain **provisional**, subject to verification of original documents and fulfillment of all eligibility conditions prescribed by Gauhati University.
